Article I – Name of the Organization

Article IV – Membership

- General Membership**
 - UHESA general membership consists of ~~all staff members of USHE institutions~~ represented by staff associations. ~~Representation on the UHESA Board is~~ determined by each staff association.
- Representation**
 - The UHESA Board (see Article V – Officers) represents the interests of the General Membership. Delegates from each institution represent their constituents by means of participation in general meetings, ~~the annual conference,~~ and other communications and events.

Article V – Officers

- Composition of the UHESA Board**
 - Officers of UHESA include delegates from each institution and members of the UHESA Executive Board. Together, these two groups comprise the UHESA Board.
- Delegates**
 - Composition
 - Each institution shall appoint at least two delegates and two alternate delegates to the UHESA Board. ~~Roles and responsibilities of delegates are outlined in the UHESA Bylaws.~~
 - Term of Office

- c. Selection
 - iii. ~~Selection of delegates and alternates occurs per the process outlined in the UHESA Bylaws.~~

3. Executive Board

- a. Composition
 - iv. The UHESA Executive Board shall consist of ~~the~~ President, President-Elect, Immediate Past-President, Secretary, Treasurer, ~~Communications Officer, Government Relations Officer, and Professional Development Officer,~~
- b. Term of Office
 - v. All members of the Executive Board serve for ~~at least~~ one year ~~after elected~~. ~~President-Elect serves for three years, to allow service as President and Immediate Past-President.~~
- c. Selection
 - vi. Executive Board members ~~shall~~ be elected from among the UHESA delegates, ~~alternates,~~ or from the general membership of UHESA. ~~Roles and responsibilities of Executive Board members are outlined in the UHESA Bylaws.~~ Elections are held ~~prior to the~~ annual UHESA Conference each year. Executive Board members may hold only one seat on the Executive Board.

Article VI – Meetings

- 1. Frequency
 - a. The UHESA Board shall have a minimum of one conference annually. ~~UHESA shall convene a general meeting and executive meeting regularly, on a schedule determined by the President.~~
- 2. Open Meetings
 - ~~b.~~ All general meetings will be open meetings; however, the Executive Board may designate a meeting or a portion of a general meeting as an executive session and may limit attendees to the delegates.
 - c. ~~When official UHESA business is conducted at a general meeting, a quorum, which is a two-thirds majority of the voting members, must be present to conduct a vote. A vote passes with a simple majority of members present.~~
- 3. Special Meetings
 - d. Special meetings may be called by the UHESA President or by a majority of the Executive Board. ~~Special meeting decisions will be communicated to the general membership, at the discretion of the Executive Board, by the President or designee.~~

Article VII – ~~Amendments~~

- 1. Proposal
 - a. Amendments to this Constitution may be proposed by any member of the UHESA Board.
- 2. Approval
 - a. Proposed amendments to this Constitution must be approved by a two-thirds majority vote of the UHESA ~~Executive~~ Board.
